

## MemBrain End User License Agreement

**IMPORTANT:** This software End User License Agreement (EULA) is a legal agreement between you and Thomas Jetter. Read it carefully before completing the installation process and using the software. It provides a license to use the software and contains warranty information and liability disclaimers. By installing and using the software, you are confirming your acceptance of the software and agreeing to become bound by the terms of this agreement. If you do not agree to be bound by these terms, then select the "cancel" button, i.e., do not install the software.

This EULA shall apply only to the MemBrain software supplied by Thomas Jetter herewith and the MemBrain DLL supplied by Thomas Jetter herewith regardless of whether other software is referred to or described herein.

### DEFINITIONS

- (a) "Thomas Jetter" means Thomas Jetter, Münchhofstr. 43, 55246 Mainz-Kostheim, Germany
- (b) "MemBrain" and "Software" refers to Thomas Jetter's MemBrain Neural Network Editor and Simulator program and the MemBrain Script debugger application, in each case, supplied by Thomas Jetter herewith, and corresponding documentation, associated media, and online or electronic documentation.
- (c) "MemBrain DLL" refers to Thomas Jetter's MemBrain DLL (Dynamic Link Library) only, in each case, supplied by Thomas Jetter herewith, and corresponding documentation, associated media, and online or electronic documentation.

The MemBrain program and all associated supplementary software including but not limited to the MemBrain Script Debugger, the MemBrain DLL and all MemBrain generated source code are distributed "as is". No warranty of any kind is expressed or implied. You use it at your own risk. Thomas Jetter will not be liable for data loss, damages and loss of profits or properties or any other kind of damages or loss caused by use or misuse of this software.

### RESTRICTIONS

You may not use, copy, emulate, clone, rent, lease, sell, modify, decompile, disassemble, otherwise reverse engineer, or transfer any version of the Software, or any subset of it, except as provided for in this agreement.
